LEGAL SERVICES BOARD COSTS STATEMENT 2019/20


This statement details our costs for the financial year from 1 April 2019 to 31 March 2020 and the position at the start of the 2020/21 financial year.



2019/20 Levy

The LSB is publicly funded although our costs are recovered from a statutory levy on the approved legal regulators, who in turn derive their funding from fees paid by the legal profession. For 2019/20 we levied the following on the approved regulators:

If averaged across all those authorised to undertake reserved activities, our levy in 2019/20 would be

£21.27

(an increase of 6.3% compared to 2018/19).

At 1 April 2020 the LSB provided oversight for

authorised to undertake reserved legal activities. (2.5% more than 1 April 2019).

Reserves



As at 1 April 2020 our reserves were **£6,367k**

(the same as in April 2019).

Staff costs

In 2019/20, our average staff head count was **31.4 full time equivalent members of staff** (4.2% lower than 2018/19).



Overall staff costs were £2,218k (0.9% lower than 2018/19).

As at 1 April 2020 our CEO's annual salary rate was **within the range of £135k - £140k** (the same range as at 1 April 2019).

The salary of the highest paid employee for 2019/20 was

2.68 times the median salary

of the workforce, which was £51,302 (down from 3.27 times in 2018/19).
